To conform to the payment policies prescribed by the Association for prompt payment of internet service. The Member recognizes the right of the Association to terminate internet service for nonpayment of delinquent accounts, as further provided under its policies and procedures, and the Association is hereby released from any liability or damage which may result from the termination of the internet to the member should he/she fail to comply with the payment policy.
